Chief's Monthly Report: 2020



The Austin Police Department as of January 1, 2019, became a National Incident-Based Reporting System (NIBRS) reporting agency. As a result, the following report includes comparison crime data as of January 1, 2020 citywide and by sector. Additionally, provided is a map of the APD sectors and a reference guide to the NIBRS codes associated with the crime categories. Crime is now reported by persons, property and society.
