In reporting information required by this form, a City official shall include the same information as it pertains to his or her spouse or domestic partner, by separate listing. However, a separate report for the City official's spouse or domestic partner is not required.

Per City Code Section 2-7-72, when completing this mid-year update to your annual statement, **only include changes** in your disclosed information that constitute a "substantial interest" under City Code Section 2-7-2(10) and (11) that have occurred since your last filed annual Statement of Financial Information.

Where a monetary amount or value of income of an asset is required to be reported, the exact amount need <u>not</u> be reported. The statement may instead include the category or amount as follows:
