Community Meeting #1 Summary

PARD, Studio8/Overland Partners, and Adisa Communications facilitated an open house on the Dougherty Arts Center Redevelopment Plan on Oct. 28, 2020. The project team educated more than 80 attendees about the project. A one-hour interactive Menti.com presentation was delivered on the project design, scope, and timeline. Demographic data was collected through Menti.com, and audience feedback was managed through Zoom and Public Input. Questions were taken from the audience for roughly 40 minutes and were answered by the project team and Dougherty Arts Center representatives.





Summary of Feedback Received




Participants of the Dougherty Arts Center Community Meeting #1 voiced their concerns about the new location's selection process, such as accessibility, parking, and transportation. Community members also communicated their interest in seeing the Dougherty Arts Center connect to other art institutions in the Austin area. The Dougherty Arts Center offers multiple programs in which community members expressed specific support needs such as design and lighting for theatre and visual artists. Also, community members found it necessary for the Dougherty Arts Center to embrace diversity and inclusiveness and incorporate those elements into programs the center would offer.



Demographics




Public Input

- 2. Theatre performances, dance performances, classical concerts, visual arts exhibitions, and educational events such as interviews and round table discussions with artists.
- 3. The gallery space, auditorium, and classrooms add to the ability of Austinites to experience art and improve the QOL here.
- 4. Art gallery and artists talking about their work.
- 5. A nice receptionist and opportunities to show work.
- 6. Since the new DAC is so close to the trail, I can imagine luring trail users to use the facility and attending the DAC events.
