# **Community Meeting #2 Input Summary**

PARD, Studio8/Overland Partners, and Adisa Communications facilitated an open house on the Dougherty Arts Center Redevelopment Plan on Jan. 26, 2021. The project team educated 24 attendees about the project and the landscape design. We delivered a one-hour interactive Menti.com presentation on the project design, scope, and timeline. We collected Demographic data collected through Menti.com; we managed audience feedback through Zoom for this community meeting specifically. Questions were taken from the audience for roughly 40 minutes and answered by the project team and Dougherty Arts Center representatives.





## **Summary of Feedback Received**



Participants of the Dougherty Arts Center Community Meeting #2 were given an opportunity to voice their opinion through Menti.com on which design option they preferred and least preferred. Of the 24 attendees, the majority chose Option 1B, where the City of Austin Parks and Recreation Department office remained, and the Dougherty Arts Center developed separately from the PARD office. Community members also made clear to the project team that courtyards and green spaces were vital to the Dougherty Arts Center's development.




## **Demographics**


