The Dougherty Arts Center (DAC) is one of Austin's oldest community art venues. Formally a Naval and Marine Reserve center, built in 1947, the building was dedicated to the City in 1978. While the DAC has brought dynamic, creative, and cherished arts to Austinites for many years, the facility's infrastructure is in decline. The center increasingly faces challenges such as lack of flexibility and space, aging building systems, and the presence of hazardous building materials. Furthermore, the center is located within the FEMA-designated 25-year flood plain and sits atop a former landfill.

The DAC is proposing to relocate the center to a space that better responds to the needs of users and staff as well as provide an environment that enhances the mission of the DAC: to support emerging through established artists by creating opportunities to create, showcase and experience art first hand.
