Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On 8/17/2018, at approximately 1:00am, several officers responded to gunshots being fired in the vicinity of the north alley, in the 300 blk of E. 6th Street. Downtown Patrol officers began to converge on the alley from the east and the west. Officers then began to give chase to a B/M suspect who may have been involved in the gunfire, running eastbound through the north alley from San Jacinto Blvd. Several other officers were staged east of the fleeing subject, near the intersection of the north alley and Trinity St. The fleeing B/M suspect emerged from the alley and onto Trinity Street, in front of the officers awaiting there. The suspect was armed with a firearm in one of his hands. As he crossed in front of the officers, the suspect's hand, holding the weapon, moved in a direction towards the officers, and multiple officers fired upon the suspect, striking him. The suspect fell to the ground. He was taken into custody and EMS was summoned to the scene. Upon EMS arrival, the suspect was transported to the hospital. He was pronounced deceased at 1:22am.
