On 3/17/2019, several on-duty Austin Police Officers were working in the downtown area for the SXSW music festival. At approximately 2:50am, two civilian vehicles approached the red light located at the intersection of E. 7th Street and the service road of IH 35 southbound, in Austin, Travis County, Texas. Minutes prior, these same two vehicles were involved in a minor collision with one another at 7th St/ Neches St. One of the vehicles was a black Maserati. The other vehicle was a black Chevrolet. When the vehicles stopped at the red light, two occupants of the Maserati got out of their vehicle and approached the driver's side of the Chevrolet. After a brief conversation, one of the occupants that had exited the Maserati, began striking the driver of the Chevrolet with a closed fist, from outside of the vehicle. The driver of the Chevrolet then began firing a firearm out of the driver's side window of the Chevrolet in the direction of the two individuals who had approached from the Maserati. The driver of the Maserati fled back to the driver's seat of the Maserati. The other passenger of the Maserati ran around the front of the Maserati and displayed a firearm, then fired upon approaching police officers, and got into the backseat of Maserati. Multiple officers returned fire on the subject who fired upon them. Both vehicles then fled from the scene eastbound on 7th Street. At approximately 12pm on 3/17/2019, the black Maserati was located in the 4200 blk of Tilley. The decedent was discovered in the backseat of the vehicle apparently deceased. The decedent was pronounced deceased at 12:13pm.
