## Chief's Monthly Report

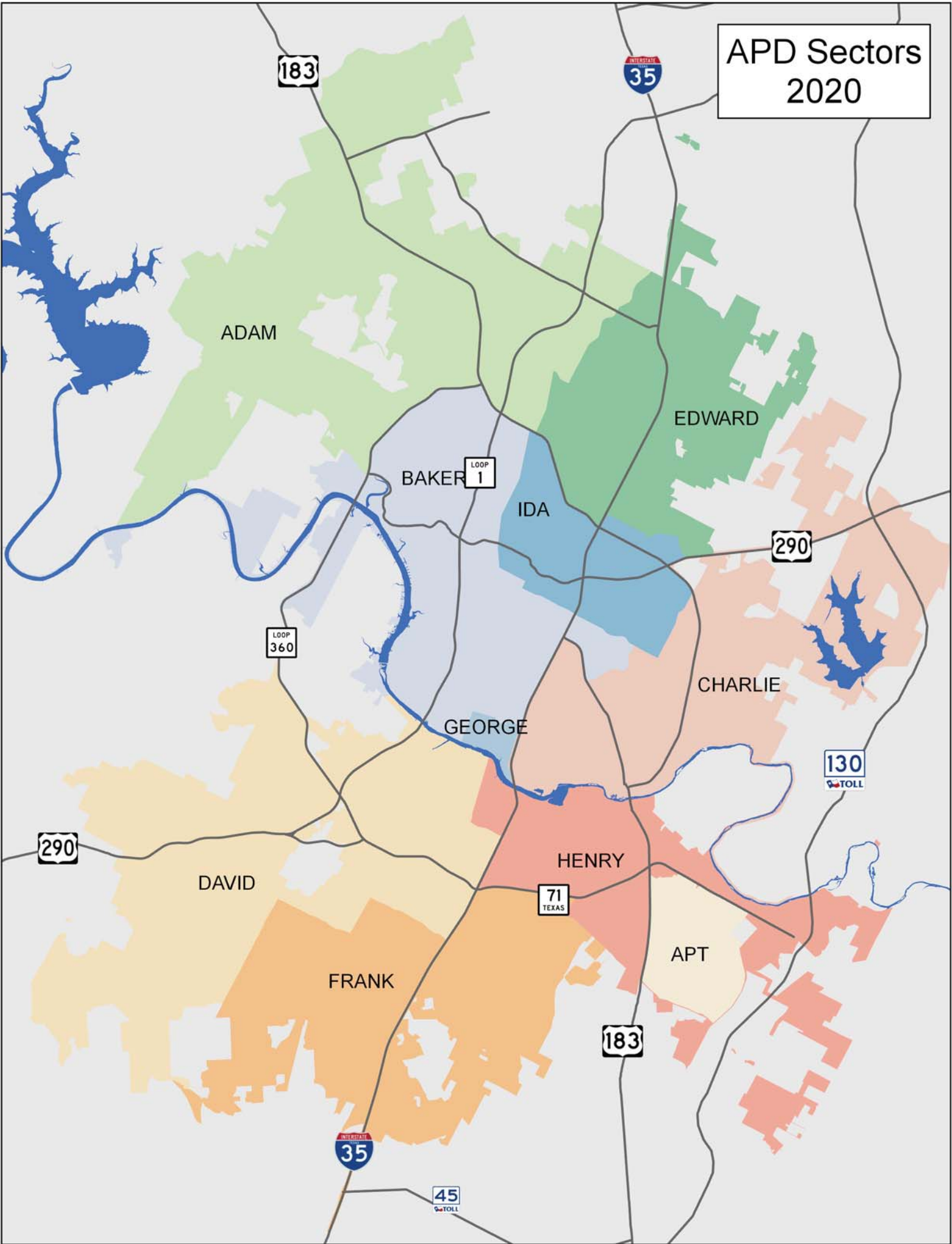
